The terms of reference of this SIMC:

1. Undertake field visits to District in connection with effective implementation of the PC-PNDT Act, 1994.
2. Convene Meetings with members of the District Appropriate Authority and District Advisory Committee to monitor the implementation of the PC-PNDT Act, 1994.
3. Evaluation of records maintained by the District Appropriate Authority including examination of the consolidated reports of Form 'F' submitted by all registered USG clinics by the 5th of every month.
4. Random inspection of records maintained by the facilities including registration (Form-A). renewal, Form-F etc., as per the provision of the PC-PNDT, 1994.
5. Search/seizure of records/Instruments of facilities by District Appropriate Authority, including building up a strong case for conviction of offenders with regards to non-registration of facilities, non-maintenance of records, carrying out sex determination, advertisement of sex determination, violations of any provision of the PC-PNDT Act.
6. Follow-up with the District with regards to action taken report and court cases against violation under the Act.
